During her visit at UNHLS on 15th March 2017, The PS, Dr. Diana Atwiine chaired a meeting that discussed the fate of NTRL assets in Wandegeya, Pathology Services, Procurement of Hepatitis B reagents and the National Scheme of Service for lab professionals, among others. Most importantly, the PS issued a Press Statement to announce how the international accreditation of the Molecular Virology laboratory at UNHLS by SANAS for a defined scope and the operation of a quality management system in Medical Testing Laboratory under ISO standard 15189. This addresses the challenge of testing specimens for complex diagnostic and forensic purposes from all districts of Uganda. M&E Training for Regional Laboratory Coordinators

Indicators are very key in quantifying the desired progress of laboratory services. This is one of the reasons why a training for regional laboratory coordinators was conducted at UNHLS/NTRL on 13th March 2017. All 14 regional lab coordinators including; the China/Uganda friendship Hospital and Prison health services with 22 laboratories; reviewed a list of indicators, agreed on targets and adopted a quarterly report template. This will initially enhance the monitoring and evaluation of the progress of laboratory services at regional level and later progress throughout the entire laboratory network.
